Call to order

Roll call

Reading and approval of previous AGM minutes (to be sent to GRU Yahoo Group)

Minutes from 2008 AGM were not presented.

Prior year Secretary took the minutes at the 2008AGM, and were not transmitted.

## Greeting – Lex

- -Accomplishments -membership up 24%, Atlanta and other teams performed very well.
- Discipline individuals teams involved handled themselves well.

USA Rugby Nigel's Report. USA Rugby Congress/GRU/South commentary and news. Presented marketing accomplishments for members consideration. TV coverage increased from 2 hours national in 2006 to almost 300 hours national in 2009. Danita voted at Congress (?) to approve state based unions.

## Treasurer – Gary Kent – Reports attached:

Better collections year over year.

P/L Budget v Actual: Loss relates to \$3000 approved deficit spending for website. Only \$150 actual was spent in previous year.

All within budget except for special sponsorship payment to support GRU team Renegades to travel to Final4 in Denver Div1 Championship.
All activities at or under budget.

Referees – Peabody explained 3 ELV's not accepted.

Seeger- needs help for more recruitment of referees

Open discussion- challenges of training new referees.

- Need for \$100k insurance per player
- CIPP will NOT pay for player injury
- CIPP coverage is considered 3<sup>rd</sup> party liability insurance only.
